### Rookies and Below

- 100% refund before March 1<sup>st</sup>.
- 75% refund before March 8<sup>th</sup>.
- 50% refund up to 1<sup>st</sup> game of the year.
- There will be no refunds after the player's team plays its first official little league game, except in exceptional circumstances.
